- 2. The Remote e-voting period remained open from Friday, September 26, 2025 (9.00 a.m. IST) and ended on Monday, September 29, 2025 (5.00 p.m. IST).
- The cut-off date for the purpose of determining the entitlement for voting through 'Remote e-voting' or 'Polling Paper, on the proposed resolutions was September 23, 2025.

- 4. At the 40th AGM, after the declaration of poll by the Chairman, two ballot boxes kept for the Polling were locked in my presence with due identification marks placed by me.
