

I, Pragnya Parimita Pradhan, Company Secretary in Whole Time Practice, having office at 46, LGF, Jor Bagh, New Delhi-110003, has been appointed by the Board of Directors of Atlantic Commercial Company Limited ("the company"), as scrutinizer for the purpose of scrutinizing the 'Remote e-voting process' and voting through 'Polling Paper' at the 36th Annual General Meeting (AGM) of the members of the Company, in a fair and transparent manner and ascertaining the requisite majority on 'Remote e-voting' and voting through 'Polling Paper' carried out, as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and the Companies (Management and Administration) Amendment Rules, 2015 and as amended from time to time, on the resolution set out in the notice dated August 12, 2021 of the 36th AGM of the members of Atlantic Commercial Company Limited, held on Tuesday, September 28, 2021 at 11:00 A.M., at Unit No. 2053, 2nd Floor, Plaza-II, Central Square, 20, Manohar Lal Khurana Marg, Bara Hindu Rao, Delhi-110006.

Accordingly, I submit the Report, on completion of Remote e-voting process and voting through polling paper, as under:-

 The Company has engaged the services of National Securities Depository Limited ('NSDL') as the Authorized Agency to provide secured system for Remote e-voting process.

- The Remote e-voting period remained opened from Saturday, September 25, 2021 (9.00 a.m. IST) and ended on Monday, September 27, 2021 (5.00 p.m. IST).
- The cut-off date for the purpose of determining the entitlement for voting, through 'Remote e-voting' or 'Polling Paper, on the proposed resolutions was September 21, 2021.
- At the 36th AGM, after the declaration of poll by the chairman, two ballot boxes kept for the Polling were locked in my presence with due identification marks placed by me.
- 5. The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The Poll papers were reconciled with the records maintained by the Registrar & Share Transfer Agents of the Company i.e. M/s MCS Shares Transfer Agent Limited ('MCS') and the authorization / proxies lodged with the Company /MCS.
- The polling papers, which were incomplete and /or which were otherwise found defective have been treated as invalid and kept separately.
- 7. After counting the votes casted by the members and proxy holders present at the 36th AGM, through polling papers, the votes cast through Remote e-voting were unblocked on September 28, 2021 around 11.45 a.m.
