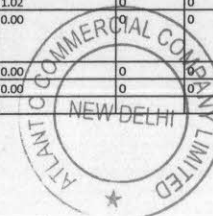
* Please note that Aggresar Leasing and Finance Private Limited, Betterways Finance & Leasing Private Limited, Lotte Trading and Allied Services Private Limited, Lotus Finance and Investments Private Limited, Midopa Holdings Private Limited, Xonix Enterprises Private Limited were part of 'Promoter and Promoters Group' of Atlantic Commercial Company Limited. All these companies collectively held 5,09,600 equity shares of Atlantic Commercial Company Limited in their respective 6 different demat accounts. However pursuant to sanction of Scheme of Amalgamation ('Scheme') by Hon'ble Delhi High Court and its becoming effective from August 26, 2016, Betterways Finance & Leasing Private Limited, Lotte Trading and Allied Services Private Limited, Lotus Finance and Investments Private Limited, Midopa Holdings Private Limited, Xonix Enterprises Private Limited (collectively referred as 'Transferor Companies') have been merged into and with Aggresar Leasing and Finance Private Limited ('Transferee Company') and all the assets and liabilities and entire businesses of 'Transferor Companies' have been transferred/vested into the Transferee Company and the said Transferor Companies ceased to exist from the said effective date. Due to same, aforesaid 5,09,600 equity shares of Atlantic Commercial Company Limited held by all these companies have been shown here as held only by Transferee Company (i.e. Aggresar Leasing and Finance Private Limited) under heading 'Promoters and Promoter Group'.
